The above rules have resulted in a general rule that FERS employees should retire on December 31 st and CSRS employees should retire on January 3 rd if they wish to maximize their lump-sum leave payments. Of course, general rules have exceptions and, for the last two years, January 3 rd has not been the "best" date to retire for CSRS employees.

CSRS and FERS Retirement Eligibility and Available Options.

The retirement day can be a workday, a non-workday or even a holiday. Retirement dates often coincide with special dates such as, your birthday, attaining 30 years of service, the holiday season, the end of the year or another personal event. However, the selection of a retirement date can have significant financial consequences.

Best Dates to Retire 2016

Your first retirement payment for that month would be 29/30, 28/30 or 27/30 of the first month's payment. So, for CSRS employees, the following 2016 dates are interesting: March 3 April 1 Sept. 2 These dates allow the accrual of the last accumulation of annual and sick leave credit.

The Best Day to Retire | Federal Employee's Retirement ...

If you are a CSRS employee working Monday through Friday, and you are considering retirement dates of Friday the first, Saturday the second or a Sunday the third, Friday might be the best day to retire. This is because Saturday and Sunday are your days off, so you do not receive pay for those days from your job.

Picking the best date to retire. If you are a FERS employee who retires on January 1 instead of December 31, you won't be on the annuity roll until February 1, and you won't receive your first month's annuity payment until March 1. The same delay applies if you are a CSRS employee who retires on January 4 instead of January 3.

If you retire for disability, you may be guaranteed a minimum annuity equal to the smaller of: 40 percent of your "high-3 average salary", or; the regular annuity obtained after increasing your service by the time between the date of your retirement and your 60th birthday.

For end-of-year retirees, the best near future date to retire is Jan. 3, 2017. Doing that gives you the maximum lump sum payment for unused annual leave. If the 1.6 percent pay raise goes into effect — as appears likely — most of that annual leave will be paid at the new higher rate.
