REQUIRED VS-300 FORM – Certificate of Divorce. When you file for divorce in Kentucky, you must file a VS-300 form with the court clerk. While all other self-help forms may be submitted with hand-written entries, the VS-300 must be typed. You must complete the form online at [this link](#). Please read instructions for completing the form. You must print this document on 25% Cotton Bond Paper with a visible watermark.
